

From the North (from Occoquan or Lorton) come down Route 1 and turn left on Rippon Boulevard. Coming from the South, turn right on Rippon Boulevard. From Dale City, take Dale Boulevard and cross Rte. 1 to Rippon Boulevard. Continue on Rippon across Blackburn Road (4-way STOP) and take the 4th left on to Marsh Overlook Drive. Take the 2nd right on to Eiderdown Court. 1414 is the third house on the left. There is plenty of room to park along the road or in the cul-de-sac.

Just for confusion, sometimes people miss the first Marsh Overlook. If after the 4-way at Blackburn Road, one comes to a second 4-way Stop, also Marsh Overlook, turn left and take the second left on Eiderdown.

AAUW State Conference

Civil Right Act (CRA) of 1964 Panel

The CRA panel looked at how the CRA happened, its effect in Virginia and its effect on women. The CRA, which is 50 years old this year, was originally designed to bar discrimination based on race, color, religion, or national origin. Howard Smith, a Virginia Democrat who chaired the House Rules Committee and who strongly opposed the CRA, added the prohibition of discrimination based on sex to it. Panelist Milton Rowan said Smith called it "ladies day in the house" and that Smith hoped adding sex would defeat the bill because northern Democrats who opposed civil rights for women would vote against the bill. Carla Whitfield started her presentation by singing a slave song for freedom. She talked about her experience as one of the first African American to go to a previous "Whites only" elementary school in Virginia. She said her Kindergarten teacher was a positive force, but many people, especially adults, opposed integration. Many VA laws and acts, such as the "Freedom of Choice Plan" did nothing to integrate schools.

AAUW at the White House

How did I get that invitation to attend the White House Equal Pay Day event on April 8? It all started with a program at one of our meetings a year or so ago when staff from AAUW asked attendees for personal stories of pay discrimination. I volunteered my story and was interviewed by Liz Owens. That story was on the AAUW website last year and in it I told about my first job after college graduation as a third grade teacher. When I was told my salary, there was an indication that "head of the household" was given \$500 more. Apparently, "head of the household" meant "male" because I did not qualify even though my husband was still in college and I was the sole breadwinner!

Liz Owens called me last week and asked if I would like to attend the White House event on Equal Pay Day and I was thrilled to say yes. My first thought was how would I get there? Driving in Washington is not something I am willing to do. Luckily, I have a great friend, Jim O'Connor, chair of the Coles Magisterial District Democratic Committee, who volunteered to get me there and home again. I met the two AAUW staff people, Liz Owens and Deborah Swerdlow, at the visitors' gate on 15th and Hamilton at 10 am. From that point, the White House cannot be seen. The gate was opened and we started our journey which would end up in the East Room of the White House. We had to show our ID at several checkpoints and purses had to go through a conveyer belt x-ray similar to security at airports. Once we were inside all White House staff seemed very friendly and each one said "Welcome to the White House." We arrived at the area right outside the East Room which was so beautiful with gorgeous chandeliers and walls lined with portraits of former presidents. We waited there until about 11 am at which time the doors were opened and we filed into the East Room which was lined with chairs for all, TV cameras lined up against the far wall and the podium in the front. Once again, the beautiful chandeliers and the friezes and molding on the walls made this such an impressive setting. The first six rows were reserved for dignitaries who eventually came in and that was exciting to recognize people who are frequently seen on TV. Our seats were about 3 rows behind the dignitaries so we could see the podium clearly. And then came the announcement: "Ladies and Gentlemen, the President of the United States"! We all stood and clapped and I had a hard time believing I was actually there. Lily Ledbetter told her story and then introduced the President. President Obama's remarks have been in the news frequently but what I remember the most is his statement that some people call the gender pay gap a myth. President Obama said, "It is not a myth. It is math." Women earn 77 cents for every dollar earned by men and I thought about the button I had in my purse that said 59 cents. I have had that button since the 1970's when I first began to work for equal pay. Women have made gains in the past 40 years but we do not receive equal pay yet.

After the event, I had my picture taken with Linda Hallman, AAUW CEO, and with Lily Ledbetter. It was an historic day for me and it gave me a new appreciation for all the work for women done by AAUW.

AAUW of Virginia 2014 Voting Announcement

It is already time to begin thinking about AAUW of Virginia's annual one-member-one-vote election, which will take place between **April 29 and May 29**. Because paper ballots raise the cost considerably, all members are encouraged to vote online. Last year 787 paper ballots were mailed to members at a cost of \$811.73, over 40% of the total cost. Only 98 of these ballots were cast.

On the recommendation of the Voting and Elections committee, the Board voted for an opt-in rather than an opt-out process for receiving a paper ballot.

Branches can encourage online voting by bringing lap-tops or tablets to the May branch meeting to allow members to vote there.

Those who will need a paper ballot can request one between January 22 and April 6 by calling Mary K Johnson at 703/913-9490, emailing her at johnsons7703@verizon.net, or writing to her at 7703 Griffin Pond Court, Springfield, VA 22153. She will need each member's AAUW ID number, branch, and address.

All members who have joined by March 31, 2014, are eligible to vote. The quorum for the election is 7% of all members of AAUW of Virginia. For more details, see the 2014 Winter/Spring edition of the Vision.
